MEMORANDUM OF UNDERSTANDING

BETWEEN

NATO RAPID DEPLOYABLE CORPS – ITALY (NRDC-ITA)

AND

CONSILIUM COMUNICAZIONE S.R.L.

ON

Subject: *Co-operation for the dissemination of communication skills and knowledge, information and partnership on communication topics.*

1. Purpose. Develop a general program aimed at creating a set of activities of interest between the two parties concerned (NRDC-Italy and Consilium Comunicazione S.R.L.) for the expansion and dissemination of communication skills and knowledge in favour of NATO.

This co-operation:

- a. Is aimed at providing tools and skills, on communication related issues, addressed to Nato.
- b. May result in providing both consultancy and advocacy for the development of an independent communication capacity whose format could be provided upon request to domestic and foreign partners. It may also result in the organization of national / regional / international conferences on communication related topics.

2. Scope.

The co-operation between NRDC-Italy and Consilium Comunicazione S.R.L. is established to provide a reference for acquiring knowledge and competence in the communications activities carried out locally or abroad by North Atlantic Treaty Organization.

3. Activities.

The activities will be performed at the most suitable location, in order to provide support and expertise to attendees on the major communication issues necessary to NATO.

Activities developed under this MOU will contribute to the establishment of a “security community” within the NATO field, developing activities like:

- a. Information = regarding communication strategies, meanings, targets, tools, goals, types, topics, offering the target groups adequate informative materials and case studies, articles, magazines and other material;
- b. Education = training programs;
- c. Practise = exercises on specific issues.

Administrative and financial details concerning each activity will be agreed on a case-by case basis.



4. Commencement, amendment and termination

- a. The present MOU will enter into force on the date of the last party's signature;
- b. This MOU can be amended at any time in writing by the mutual consent of the signatories, subject to prior acceptance of the proposed amendments by the other signatory;
- c. The parties may withdraw from this MOU by giving 6 months prior notice in writing to the other party;
- d. Any dispute regarding the interpretation or application of this MOU shall be resolved by consultation between the parties;
- e. This MOU is signed in two original copies both in English language.
